2. Pallets to be held in place with proper blocking and bracing. All packaging, blocking and bracing to be in full compliance with the ISPM-15 standards for wood packaging materials.
3. All containers entering U.S. ports must be sealed in accordance with the ISO/PAS 17712 standard. All ocean containers destined or transiting the U.S. must be secured with a bolt type seal at origin.

Force majeure:

Force majeure: Neither party shall be held responsible for the delay or failure of performance obligation provided for herein when such delay or failure is caused by strike, fire, flood, act of god, earthquake and any laws, rule or regulations of any governmental authority or other conditions beyond its control which cannot be forecast or provided against and provided the party subject to such obligation shall have exhausted alternative means of performing the obligation in question.

The party wishing to claim relief by reason of any said circumstances shall notify the other party in writing of the intervention and of cessation's and then deliver a certificate issued by the Chamber of Commerce at the place where the accident occurred as evidence thereof. The event of a delay by such force majeure exceeds 60 days, each party shall have the right to cancel this contract, unless otherwise agreed in such case, and neither party shall have the right to claim eventually damages.

Arbitration :

Arbitration : In case of dispute and if the contracting parties cannot reach an amicable settlement of any claim concerning this contract within 60 days from its occurrence, the case will be transferred to Foreign Trade Arbitration Commission of the China Council for the Promotion of International Trade.
